Thank you for your letter dated 03-03-1988 which has been directed to us for reply.

Our production records indicate that your PORSCHE 914 is indeed a limited edition model and is one of approx. 800 vehicles that were exported in the U.S. in model year 1974. The vehicle was called the Can-Am edition and all had the same two tone colour in two different versions. The vehicles were either black with yellow bumpers, side panels and wheels or light ivory with phoenix red bumpers, side panels and wheels.

Your 914 was manufactured in April 1974 and left the factory with the following specifications:

Engine number: 012838

Colour: two tone light ivory/phoenix red


Options: Can-Am edition, tinted windows, painted bumpers.


